

# Privacy

Data Group Industries, Inc. appreciates your interest in this Web Site and other related or linked Data Group Industries, Inc. sites (the "Web Site"). This Privacy Policy applies and is limited to treatment of information that is collected via the Web Site or used as a result of the Web Site.

## General and Policy Updates

## Information We Collect
